Today's Market View

The DSE broad Index- DSEX closed in green today. The benchmark index declined by 33.7 points or -0.7% and closed at 4678.4 points today. The blue-chip index DSG3 and the shariah based index DSES both closed in red, closing to 1626.6 and 1074.6 respectively. Turnover stood at BDT million 2690 (USD 31.7 million), about 17.47% lower than the previous trading session's value. Most of the sectors witnessed bearish performance today, Jute Sector (-4.45%) was the highest gainer followed by General Insurance Sector (+1.4%) whereas Paper Printing Sector (-3.2%) was the highest toser followed by Engineering Sector (-1.2%), MTLTURES (-2.7%) was the highest traded share with a turnover of BDT 128.7 million followed by BRACRAINK (-0.4%) and NORTHERN (7.5%) respectively. Engineering sector has highest turnover of 15.5% in the market. SAMATALETH (+9.9%) was the today's top gainer while WMSHIPYARD (-12.0%) was the top

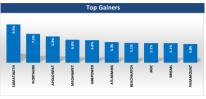
