The DSE broad Index- DSEX closed in red today. The benchmark index decreased by 48.2 points or 0.8% and closed at 5763.7 points today. The blue-chip index DS30 and the shariah based index DSES both closed in red, closing to 2024.7 and 1320.3 respectively. Turnover stood at BDT million 8128 (USD 97.9 million), about 5.15% higher than the previous trading session's value. Most of the sectors witnessed bearish performance today. Pharmaceuticals Sector (+1.2%) was the highest gainer followed by Food & Allied (+1.1%) and Ceramics (+1.1%) respectively whereas General Insurance sector (-5.1%) was the highest loser followed by IT (+3.2%), Service & Real Estate (-2.3%) respectively. UPGDCL (+0.5%) was the highest traded share with a turnover of BDT 665.6 million followed by MONNOCERA (+3.9%) and FORTUNE (+9.2%) respectively. Banks sector has highest turnover of 16.9% in the market. FORTUNE (+9.2%) was the today's top gainer while ACIFORMULA (-9.5%) was the top loser today.




