IFICLISLMF1, GENNEXT and AGNISYSL were the top three losers today.




The DSE broad Index- DSEX colsed in slight green today. The benchmark index advanced by 4.2 points or 0.1% and closed at 7060.8 points today. The blue-chip index DS30 has closed in red by 8 or 0.3% to 2683.3 and the shariah based index DSES declined by 0.7 or 0.0% to 1484.1 respectively. Turnover stood at BDT million 15,070 (USD 175.6 million), about 1.02% higher than that of the previous trading session's value. General Insurance (+4.8%), Life Insurance (+4.4%) and Tannery Sector (+3.3%) were the top gaining sector whereas Jute (-1.1%), Ceramics (-1.1%) and Miscellaneous (-1.0%) were the top three loosing sectors respectively. Bank Sector generated highest turnover position of 24.6% in the whole market. IFIC, BEXIMCO and DELTALIFE were the most active stocks in the market. EIL, INDEXAGRO and JANATAINS were the today's top three gainers while




