Today's Market View

The DSE broad Index- DSEX closed in red today. The benchmark index declined by 57.7 points or 1.1% and closed at 5357.5 points today. The blue-chip index DS30 and the shariah based index DSES both closed in red closing to 1883.5 and 1233.5 respectively. Turnover stood at BDT 5801 million (USD 69.9 million), about 21.86% lower than the previous trading session's value. Most of the sectors witnessed bearish performance today. Food & Allied sector (+0.1%) was the highest gainer, whereas Paper & Printing (-3.8%) was the highest loser, followed by Jute (-3.7%) and Engineering (-2.9%). KPCL (-6.1%) was the highest traded share with a turnover of BDT 648.8 million followed by UPGDCL (-3.1%) and SHASHADNIM (-2.2%) respectively. Banks sector has highest turnover of 16.9% in the market. ISNLTD (+9.9%) was the today's top gainer while INTECH (-9.9%) was the top loser today.




